PROGRAM LICENSE PURCHASE AGREEMENT

THIS AGREEMENT is effective this _____ day of _____, 200____ (the “**Effective Date**”) by and between Global Ventures SA, d/b/a Travel Choice International (“**TCI**”), whose mailing address is 905 Nelson Ave. Keystone, SD 57751 and _____ (“**Licensee**”), whose address, telephone number, facsimile number and e-mail address is _____

For and in consideration of payment of the Purchase Price by Licensee to TCI, TCI agrees to sell, and Licensee agrees to purchase, a Program License in accordance with the Terms and Conditions set forth herein or on the reverse side hereof. Licensee agrees to pay the Purchase Price to TCI in cash or in accordance with the credit terms attached hereto. TCI agrees to deliver to Licensee the services which are associated with a Program License, subject to such Terms and Conditions. Licensee understands that this Agreement, as well as term of the Program License, is valid for one (1) year from the date shown above and must be renewed annually. Licensee has also read and understood the Program Rules and Regulations and agrees to abide by them as they may be amended by the Program Administrator from time to time.

TCI, through the Program Administrator, shall make available to Licensee the services of reservation specialists and access to reservations for condominium unit rental accommodations, pursuant to the Program Rules and Regulations. Reservation requests must be reserved either on-line through our website at “www.travelchoiceinternational.com” or by calling the Reservation Center at (866) 824-4753. It is recommended that reservation requests be made at least ninety (90) days in advance of the desired date you wish to reserve your accommodations. However, last minute reservations may be available by selecting from the available inventory listed on our website. Reservations are for Licensee’s personal use only and may not be rented, given away or otherwise transferred to a third party.

MEMBERS’ RIGHT TO CANCEL

If you wish to cancel this contract, you may cancel by delivering or mailing a written notice to the membership travel operator. The notice must say that you do not wish to be bound by the contract and must be delivered or mailed before midnight of the third business day after you sign this contract. The notice must be delivered or mailed to: Travel Choice International, 905 Nelson Ave. Keystone, SD 57751. If you cancel, the membership travel operator will return, within ten days of the date on which you give notice of cancellation (and return all sales materials), any payments you have made.
